### Standards for the maintenance of supervision status

The AHA has a recognised high standard for clinical supervisors. In completing this form, supervisors are encouraged to reflect and ensure that the minimum standards for supervision status are met and maintained.

- A minimum of 2 hours of supervision (supervise the supervisor) per year; OR
- 4 hours of supervision of supervisors in a group situation
